IEEE THOMAS TERMS OF USE

The following Terms of Use, in connection with the [IEEE Terms and Conditions](#), [Copyright Policy](#), and [Privacy Policy](#) govern your access to and use of IEEE THOMAS. By using our website, you agree to comply with these terms. If you do not agree with any part of these terms, please refrain from using our website.

These Terms of Use may be modified by IEEE at any time, without notice, at IEEE's sole discretion.

1. General

a. IEEE THOMAS is provided by the Institute of Electrical and Electronics Engineers ("IEEE") a New York not-for-profit organization with headquarters at 3 Park Avenue, 17th Floor, New York, New York, 10016.

b. Definitions

i. "Registered User" is a person no younger than 18 years of age that has registered for an account with IEEE THOMAS. Registered Users can upload and download content.

ii. "Content" refers to any information uploaded to IEEE THOMAS by a Registered User.

2. Registered User Content

2.1 Uploading Content: IEEE THOMAS allows Registered Users to upload and download Content. By uploading Content, Registered User represents and warrants that they have the necessary rights to do so and that the Content does not infringe upon any third-party rights, including copyrights.

2.2 Licenses:

Registered User retains ownership rights to their Content. However, they are required to grant the following licenses and rights to IEEE THOMAS and other Registered Users:

a. By providing Content to IEEE THOMAS, Registered User grants IEEE THOMAS a non-exclusive, worldwide, royalty-free, sublicensable and transferable right and license to use, reproduce, distribute, modify, adapt, publish, publicly perform, and publicly display the materials for the purpose of operating, promoting, and improving IEEE THOMAS, and sublicensing it to Registered Users for these purposes directly.

d. IEEE grants Registered Users a non-exclusive, personal, non-transferable license to use IEEE THOMAS in accordance with the policies and procedures of IEEE.

3. Registered User Responsibility

a. Registered User agrees and understands that:

i. IEEE THOMAS may only be used in a manner consistent with this Terms of Use.

ii. User credentials and access to IEEE THOMAS is unique to the Registered User's account. Once an account is created on IEEE THOMAS, the Registered User is responsible for maintaining the security of their account. Sharing of either is prohibited.

iii They may not remove or alter the copyright, or other intellectual property notice of either IEEE or any rights holder.

iv. The IEEE THOMAS website is made available at the discretion of IEEE. IEEE reserves the right to change, suspend, or terminate the website at any point and for any reason.

v. Registered Users who upload Content understand that the Content will be made available to all Registered Users of IEEE THOMAS for viewing, downloading, and/or reuse.

vi. Registered Users are solely responsible for the Content they upload and for ensuring that they have all rights to that Content.

vii. IEEE THOMAS is not responsible for editing, modifying, filtering, screening, monitoring, endorsing or guaranteeing any Content.

viii. IEEE THOMAS provides the website and its services on an "as is" and "as available" basis. We do not make any warranties or representations, either express or implied, regarding the website's reliability, accuracy, completeness, or availability.

ix. When using the downloaded Content, Registered User shall acknowledge the IEEE THOMAS website and the copyright owner according to academic standards of proper citation and acknowledgement of sources.

b. **Prohibited Activities:** Registered User agrees not to engage in any of the following activities while using IEEE THOMAS:

- i. Uploading or distributing materials that infringe upon any third-party rights.

- iii. Engaging in any unlawful or fraudulent activities.

- iv. Information reasonably sufficient to permit us to contact the complaining party;
- v. A statement that the complaining party has a good-faith belief that use of the Content in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
- vi. A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

5. Misuse

- a. IEEE reserves the right to suspend or cancel a Registered User account, at the sole discretion of IEEE, for any of the following reasons:
 - i. Misrepresentation of information by a Registered User;

 - iii. For the protection of IEEE THOMAS from any threat perceived by IEEE;
 - iv. If the Registered User violates the Terms of Use;
 - v. Violation of any [IEEE Policies](#);

- vii. Use of IEEE THOMAS to facilitate unauthorized public sharing of Content;
